

#### 1. BATCH REQUEST SYSTEM

Popularly known as BREQS, this system provides an offline method of encoding request for various PSA civil registry documents (birth, death, marriage and CENOMAR). The Memorandum of Agreement was entered into by the Philippine Statistics Authority and LGU-Santa Fe, Romblon on November 9, 2020. This additional service offered by our Office is of great help to the people of Santa Fe as well as to nearby municipalities whereby the constituents will no longer go to PSA serbilis outlet to secure authenticated PSA documents. BREQS is really beneficial to LGU especially this time of pandemic where travel is really limited and restricted. In addition to that, it also generates income for the LGU. Thus, BREQS, for us is service and income.


