## A RESOLUTION ADOPTING AND APPROVING THE FARM-TO-MARKET ROADS NETWORK PLAN (FMRNP) OF THE MUNICIPALITY SANTA FE, ROMBLON 2024-2026

WHEREAS, pursuant on Republic Act No. 8435 (Agriculture and Fisheries Modernization Act) Section 52, mandates the DA to coordinate with the LGUs and the resident-farmers and fisherfolk to identify priority locations of FMRS considering the number of farmers and fisherfolk and their families who shall benefit therefrom and the amount, kind and importance of agricultural and fisheries products produced in the area.

WHEREAS, on Joint Administrative Order No. 01 series of 2023 of DA, DPWH, DILG, DTI and DOT, covers the formulation and updating of Farm-to Market Road Network Plan at the national and local levels (regional, provincial, city and municipal);

WHEREAS, the Municipality of Santa Fe, Romblon, a 5th class municipality, predominantly an agriculture-based area with rice as its major crop and the municipality has many farm-to-market roads which need improvement particularly in the far-flung barangays;

WHEREAS, the Municipal Government of Santa Fe has identified the need to improve and develop the road network in the different barangays, particularly the farm-to-market roads of this municipality to enhance productivity and contribute to the social and economic growth of the community;

**WHEREAS**, the farm-to-market roads are useful, especially in terms of transportation and access to goods not only for the local residents but also for the visiting tourists.

**WHEREAS**, the FMRNP shall cover rural roads infrastructure that act or function as access roads to production areas and are not otherwise classified as national, provincial, or municipal roads.

**WHEREAS**, the importance of implementation of FMR Projects in the municipality will uplift the lives of farmers and fisherfolks, likewise it would help in the promotion of tourism in the municipality hence, this resolution becomes imperative.

**NOW THEREFORE**, after due deliberation and thorough perusal of the submitted documents, on motion of Hon. Jocel P. Galido, unanimously seconded by all other members present in session assembled, the body has -
